

Arts Access is a program designed to break the economic barriers of inaccessibility to the WNY region's arts and cultural sector. We offer increased opportunities for card members to engage and participate in their arts community.

By partnering with local theaters, galleries, and other organizations, we are able to provide free or reduced-cost admission to low-income Western New York residents and their families. In addition, we also provide a complimentary transportation service to Erie and Niagara county residents to attend a program or event.

Eligible members must currently receive income-based public assistance, such as SNAP, TANF, etc.

In a year where the majority of in-person arts and cultural programs were cancelled, ASI is especially grateful to all organizations who continued to serve our Arts Access passholders.



WNY ARTS EMERGENCY RELIEF FUND

\$235,640 Awarded to 154 Artists & Arts & Cultural Organizations

The shutdown caused by the COVID-19 pandemic profoundly impacted WNY's creative industry. With the cancellation of performances, workshops, gigs, and more, artists and arts and cultural organizations who rely on event-based income lost revenue that is essential to continue their operations.

With support from Fund for the Arts, ASI created the WNY Arts Emergency Relief Fund to ensure that WNY's rich and diverse arts sector withstood this crisis.

REOPENING TOGETHER

A PROFESSIONAL DEVELOPMENT SERIES FOR WNY'S ARTS & CULTURAL COMMUNITY

ASI began hosting the "Reopening Together" PD series to engage and support local arts administrators as we navigated the reopening process following the shutdown. Since live performances and in-person events were either cancelled or postponed throughout the year, administrators were often left with questions but no answers.

Over 200 people from various arts and cultural organizations from across WNY participated in the Reopening Together sessions. Some of the topics included Conflict Resolution, Arts vs. Covid-19, and Moving Forward Together. Participants were able to share their concerns and brainstorm together with other organizations to plan and process ideas for the arts world post-covid. These sessions also allowed different administrators to express the type of support that they still needed from the field in order to successfully navigate this process.


COFFEE CHATS

"Coffee Chats" was implemented to provide an outlet for anyone who worked in the arts to virtually share thoughts, concerns, plans, etc. and support one another at the start of the shutdown. These virtual meetings were intended to boost morale and provide emotional support in a time when the industry was not given much of it.

Most patrons do not realize the additional costs and work entailed with producing virtual events, especially for organizations that did not offer those options prior. Having these meetings gave attendees the opportunity to share ideas, vent, and request advice from others facing similar struggles.



Creative Professionals Exchange (CPX) is a two-day, professional development mini-conference for arts administrators, cultural leaders, community activists, and artists of all disciplines. This year, the COVID-19 health crisis severely impacted the industry and revealed many of the systemic issues that our community faces, including lack of access and inclusion in the arts sector.



The theme of the 2020 CPX was **"Reimagining the Creative Industry"**. It focused on how the arts can remain sustainable during the pandemic by supporting communities that were devastated by the COVID-19 crisis, and by ensuring that all art is accessible to and representative of the entire community we live in. The virtual conference took place on Nov. 6 & 7, 2020.


